

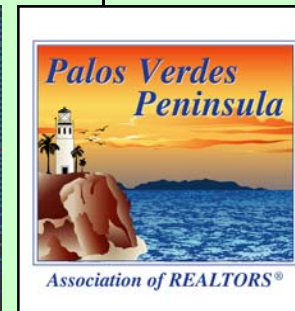

Saturday and Sunday ONLY. One sign per property, only when salesperson is in attendance, on Max 12" X 36".	One sign per home or vacant lot. Must be 10' minimum from the curb. No signs on city property or street right of way.	One sign rider ONLY, no larger than 5"x18"	18" X 30" total, including one rider. Maximum 3' high.	Sign, logo, company colors, etc., subject to written Art Jury approval prior to posting.	NO flags. NO flyer boxes.
Rancho Palos Verdes (Excluding Miraleste) 310-377-0360	SATURDAYS & SUNDAYS Only! 1-6 p.m. One sign per direction. NO LOGOS OR ADDRESSES. Max 12"x 36". Up to 3 signs per intersection allowed ONLY in public right of way. Brown & Gold except on Property	1) Saturdays & Sundays , from 1-6 p.m., lead-in signs may be used along with "Open House" sign. 2) Mon.-Fri. , one sign per property, either "For Sale/ For Lease" or open house arrow. Max 12" X 36".	One sign per street frontage.	NO "Sold" or "Leased" riders. 1) Sign must be removed when property owner is no longer soliciting property for sale or rent. 2) Other informational riders (e.g., View, Pool, etc.) are permitted.	Not over 6 square feet total, including riders. Maximum 4' high.	Any.	NO flags.
